Competition Regulations

ORGANISING PARTY

This competition (hereinafter "Competition") is run by **F.C. Internazionale Milano S.p.A.**, based in Corso Vittorio Emanuele II 9, Milan, Italian tax code 04231750151 (hereinafter the "Organising Party" or "Inter").

AIM OF THE COMPETITION

The competition aims:

- to create loyalty among those that have already signed up for a season ticket for Inter's Italian Serie A league matches at the San Siro during the 2018/19 season (hereinafter "2018/19 Season Ticket");
- to encourage new registrations for 2018/19 Season Tickets.

TERRITORY AND APPLICABLE REGULATIONS

The Competition will take place in Italy (hereinafter "Territory"), since the procedures to register for a 2018/19 Season Ticket are as follows:

- By accessing the "Season Tickets" section of the Organising Party's website (inter.it and hereinafter the "Site"), an entity with tax domicile in the Territory; in the aforementioned section of the Site, electronic payment options are available to pay the sum owed for the 2018/19 Season Ticket;
- By purchasing a 2018/19 Season Ticket from a physical sales point, all of which are <u>situated within the Territory</u>.

The applicable regulations are those binding under Italian law.

COMPETITION PERIOD AND CONTESTANTS

The Competition, which will be publicised from 9 July 2018, is reserved for all those who, as of 31 July 2018, are holders of a 2018/19 Season Ticket (hereinafter, "Eligible Season Ticket Holder").

Since minors can also qualify as an "Eligible Season Ticket Holder", the section 'CONDITIONS FOR REDEEMING THE PRIZE', contained in these competition regulations, details the applicable provisions in the even that a minor is drawn as the winner.

The prize draw will be held on 1 August 2018.

WHO CANNOT TAKE PART

The following persons may not take part in the Competition:

- persons employed by or who work with the Organising Party;
- persons who are in any way involved in the organisation of the Competition.

PRIZE

The Competition offers one prize – to be used by the winner and a guest of his/her choice – consisting of the following (hereinafter "Prize"):

- a) two return tickets to Milan, departing from the main train stations or airports in Italy or abroad (the mode of transport train or flight will be decided after the prize draw, depending on the nearest station or airport to the winner's house as well as the availability of seats especially given that the trip will be made during high season and convenience in terms of departure and/or travel time);
- b) transfer, on arrival at the train station or airport in Milan, to the Stadio San Siro;
- c) a tour of the San Siro, including a visit to the changing rooms;
- d) an exclusive pitch-side dinner for two, with a dedicated waiter, at the Stadio San Siro;
- e) transfer from the Stadio San Siro to Hotel Melià (5-star hotel);
- f) one night at the hotel, in a double room with breakfast included (check-in 10 August 2018, check-out 11 August 2018);
- g) transfer from the hotel to the train station or airport in Milan for the return journey;
- h) two official Inter home jerseys for the 2018/19 season (one for the prize winner and another for the chosen guest).

The Prize has an approximate estimated value of €3,069 (VAT included where appropriate).

CONDITIONS FOR REDEEMING THE PRIZE

Regarding the conditions for redeeming the Prize, all Eligible Season Ticket Holders should note the following:

- The Prize includes everything that is detailed in the above points a) to h); therefore, anything not expressly stated as being part of the Prize is to be paid for by the winner (for example, travel to and from the train station/airport of departure; meals other than those specified above, other extras, etc.).
- The Prize may be used exclusively by the winner and a guest of his/her choice. The winner cannot transfer

the Prize to anyone else.

- Should the winner be under the age of 18, his/her guest must be a parent or legal guardian, or an adult
 with written authorisation from the minor's parent or legal guardian to travel with the winner and use the
 Prize.
- If the winner lives outside the EU and Switzerland, it may be necessary for the winner to have a passport valid for entry into Italy.
- Should the winner be an adult and his chosen guest be a minor, the minor must be the winner's son or daughter, or under their legal responsibility; if the minor is another relative or not related to the winner, the winner must obtain written authorisation from the minor's parent or legal guardian allowing the minor to travel with the winner and use the Prize.
- Since it is necessary to provide a guarantee for the Prize to the Ministry for Economic Development, a
 conservative estimate of the Prize value has been made, taking into account a flight from abroad to Milan
 during high season; therefore if the winner lives in a place closer to Milan or in Italy, no reimbursement or
 alternative benefits will be provided owing to the difference in the cost of flights, since the Organising Party
 is only held to provide the Prize offered, regardless of the value estimated for the purposes of this
 guarantee.

TOTAL VALUE OF PRIZES

The total value of prizes to be won in the Competition is estimated at €3,069 (VAT included where appropriate).

METHOD OF ALLOCATION OF PRIZES

On 1 August 2018, a list of Eligible Season Ticket Holders for the final draw will be created. The final draw is planned for the same date and will take place in the presence of an official responsible for consumer protection and safeguarding public trust at a regional Chamber of Commerce, Industry, Agriculture and Small Business and using random-winner software (based on the RAND function in Microsoft® Excel®) with a declaration confirming the IT system's respect for public trust.

The above-mentioned software will be used to draw from the list of Eligible Season Ticket Holders:

- one winner;
- 10 reserves.

NOTIFICATION TO WINNER AND REDEEMING THE PRIZE

Once the Prize has been allocated, the winner will be contacted by email and, if needed, by telephone (using

the details provided during registration for the 2018/19 Season Ticket).

The Organising Party shall not be held responsible for the winner failing to receive notification of their success in the event that:

- their inbox is unable to receive new messages;
- the email address provided doesn't exist or is unreachable for reasons attributable to the email service provider of the recipient;
- the message containing the notification of success is mistakenly classified as junk mail or spam due to an incorrect configuration of the winner's email system or their email service provider;
- the telephone number provided doesn't exist, is unreachable or if there is no response despite repeated attempts.

The winner must confirm by email that they wish to redeem the Prize within 24 hours of being notified and must attach a copy of a valid form of ID both for themselves and their chosen guest.

If the winner is a minor, the response must come from their parent or legal guardian, with the minor copied in if possible. If the minor, when redeeming the prize, is not to be accompanied by a parent or legal guardian but by another adult, the written authorisation from the minor's parent or legal guardian allowing them to travel with that adult, as outlined in the 'CONDITIONS FOR REDEEMING THE PRIZE' section, should be sent along with ID documentation.

If the winner (or the parent/legal guardian in the case of a minor) does not respond within the above-mentioned timeframe, they will be considered unreachable and they will lose their right to the Prize. The Prize will then be allocated to the first reserve and the procedure repeated, with other reserves if necessary, until the Prize is claimed.

If the winner replies within the above-mentioned timeframe but fails to provide copies of the documents requested, or the documents are not valid, they will lose their right to the Prize. The Prize will then be allocated to the first reserve and the procedure repeated, with other reserves if necessary, until the Prize is claimed.

As soon as the winner (via their parent/legal guardian, in the case of a minor) or reserve confirms that they wish to redeem the prize, within the above-mentioned timeframe, and with the required documents attached, bookings for travel and accommodation, and other necessary arrangements for redeeming the prize, will be made.

WAIVER OF RIGHT TO RECOVER WITHHOLDING TAX

The Organising Party hereby waives its right to recover withholding tax in favour of the Competition winners in accordance with Article 30 of Italian Presidential Decree No. 600/1973.

PUBLICITY

The Competition will be publicised on the internet, in accordance with the provisions set out in these regulations.

- By way of security for the prizes offered, a guarantee has been provided to the Ministry for Economic Development.
- The Organising Party shall not be held liable for any hardware, software or connection issues that prevent
 participants from signing up, via the Site, for a 2018/19 Season Ticket, nor network connection disruption
 attributable to third parties or force majeure, which compromises the internet connection required to
 complete the online sign-up.
- The Organising Party shall not be held liable for any organisational changes relating to the Prize where
 these are attributable to third parties or force majeure (for example, adverse weather conditions, strikes or
 socio-political events that have an effect on air or rail services, etc.).
- The Prize shall be considered redeemed if, once the travel documents (train or flight tickets) and confirmation of the hotel reservation and transfer services have been sent, the winner and his/her guest do not arrive, at the time specified, at the train station or airport of departure (with it being understood that, should the train/flight depart but be subject to delays, the winner and his/her guest will be waited for). Should the winner and his/her guest not arrive at the train station or airport of departure, the winner will not be eligible for a replacement prize.
